### **TREASURER'S REPORT**

Shirley Fluharty gave the treasurer's report for March and April.

Motion to accept the treasurer's report was made by Bill Fischer, seconded by Chuck Jobe. Motion passed.

Shirley also noted that 6 clubs (Country Cousins, Country Twirlers, MVFD, Cityfolk, Swinging 8s, Whirlaways) had not yet paid the additional \$10.00 charge for insurance for the year. It had been announced at the last meeting that the insurance premium went up 30% this year and each club's share was an additional \$10.00.

### **SECRETARY'S REPORT**

Leslie Hyll filled in for Linda Rieman this evening. Motion to accept the March, 2002 minutes was made by Jean Aills, seconded by Bill Fischer. Motion passed.

### **VICE PRESIDENT'S REPORT**

Ken Allen reported that the Summer Plus workshops will begin on Monday, June 24, 2002. There will be 10 Plus workshop evenings and no DBD workshops (this is a change from the last meeting). DBD did not do well financially last year. DBD dance opportunities are still available with the Date-n-8s. Flyers for the Summer Plus workshops are not complete yet, but will be distributed to clubs in the next 3 weeks. Ken stated that the workshops are an important Council activity and good for students. Everyone should encourage students and angels to attend. There is NO free admission for angels, but experienced dancers are needed to help the less experienced dancers. Cost of the workshops is \$2.50 per person per evening, 7:30 – 10:00 pm on Mondays at the Michael Solomon Pavilion. Caller will rotate from the Miami Valley Callers Association.

Ken reported that he needs fall class info now so class flyers will be ready at the next meeting and for summer demos. Last year's flyer was passed around to be marked up.

### **PRESIDENT'S REPORT**

Auggie Auckerman reported that the Executive Committee discussed the following items at their last meeting:

- a. Dance attire – Auggie has heard complaints about proper square dance attire not being worn. It is up to the clubs to enforce or not enforce proper attire, but maybe we need to backoff the requirement to keep from losing new dancers.

- b. Other ideas discussed in the Executive Committee did not get off the ground.
- c. The secretary has had requests from a club to add items to her mailing of council minutes. She cannot send anything out to the other clubs unless it goes through the council president.
- d. PLEASE RESPOND TO RECEIPT OF MINUTES – If you receive your copy of the Council minutes by email, please reply to the message so the secretary knows you have received it. Otherwise, she must send out a hard copy.

### **TRUSTEE'S REPORT**

George Heinz had coupon books for graduates available. Please contact George to get some for your students.

George also recommended that dancers have a release form readily available in case of an accident. A dancer at the State Convention was denied access to his partner after she became ill because he was not an immediate relative.

Vicki Roush reported that she has 60 dancers on her demo list. Please realize that demos will conflict with some dances as there is a dance every night of the week. Vicki would appreciate flyers and other info about clubs other than squares to pass out at the demos.

### **NEWSLETTER REPORT**

Stuart Lewis asked that even if your club has no subscriptions to the newsletter, please see him to pick up a sheet of schedule information for your club to update. Mark it up and return it to him and he will update your schedule in the newsletter.

Stuart said he was concerned that newsletter subscriptions are down, he thinks due to the new council schedule. He has started sending email notices to subscribers that the newsletter is available on the web. He would like folks to go look at the newsletter on the web, in addition to subscribing so that he can say to advertisers that there are a lot of subscribers. If everyone would either subscribe or look at it on the web, we might be able to get enough advertisers to make the newsletter free again.

Stuart asked now that the Council schedule foldouts are out and being used, how do you like the new format? One club indicated that they preferred the older format (clubs listed by days vs. dances listed by date) (but that is not enough feedback to be able to say dancers prefer one format over another).

### **ATTENDANCE REPORT**

Stuart Lewis reported that seven clubs had NOT signed in for this meeting. He reminded representatives that they need to sign in for the club to receive attendance credit.

### **MIAMI VALLEY CALLERS ASSN. REPORT**

John Chevalier announce that MVCA had elected the following officers for 2002: President, Jason Raleigh; Vice-President, John Knight; Treasurer, Ken Roberts; Secretary, John Chevalier. It is time to recruit new dancers for fall classes. He noted that Callerlab has discussed dress including prairie skirts. He noted that they had some success with casual dress demos. Be sure when hiring a caller for a demo that the caller knows how to handle new dancers. Some apprentice callers in the area do not know how to handle new dancers.

Tom Dieterle mentioned that not many callers attended the State Convention this year and dancers complained. John said he would take that back to MVCA.

**AWARDS COMMITTEE REPORT**

No Awards report was available.

**OHIO CORPORATION OF DANCE CLUBS REPRESENTATIVE REPORT**

Barb Dieterle announced that state corp had elected new officers: President – Paul & Mary Cousino; Vice-President – Bob & Judy Calkins; Recording Secretary – Mary Ann King; Treasurer – Don & Barb Garris.

The State Fair square dance will be held on August 10, 2002 in the Rhodes Building from 5:30 – 10:30 pm. There are dressing rooms available for changing into square dance attire. Cleveland won the table of ideas at the state convention.

### **OLD BUSINESS**

Auggie Auckerman reported the following information:

- a. During the last meeting, there was a question as to whether several clubs were meeting their attendance requirement at Council meetings. The secretary checked the sign-in rosters for the last year. The July, 2001 roster was missing. Even with the missing roster, one club missed too many meetings. The club has been notified and is here tonight. **PLEASE REMEMBER – YOU ARE REMINDED AT LEAST TWICE DURING EVERY MEETING TO SIGN IN. YOU MUST SIGN IN TO RECEIVE ATTENDANCE CREDIT.** Saying you forgot to sign in will not get you credit. Attendance at four of the six meetings a year is required to maintain your club's membership in the Council.
- b. Please pick up your packets in the back. There are always several left that should have been picked up.
- c. Honor Dance, May 19, at the Pavilion from 2 – 5 pm with entertainment from 1:15 – 1:45 pm. Cost is \$4.00 for non-honor folks, free for honor folks (you need your honor badge) or council shirt. If you have not received your honor badge yet, we will have a list of people who have applied. Each club has been given a slip requesting finger foods for the dance.

### **NEW BUSINESS**

Auggie Auckerman continued with the following items:

- a. Council Benefit Dance will be held on Sunday, September 15, 2002 at the Pavilion. There will be door prizes and a raffle. Proceeds will go toward operating the Council.
- b. A nominating committee will be appointed at the July meeting. The committee will have job descriptions for all of the positions to be elected. Please volunteer to help.
- c. Earn a dangle by participating in demonstrations. See Vicki Roush for details.
- d. Substitutes for Council representatives need to understand that they have to sign in and pick up packets.
- e. Stuart Lewis and Fay Samborsky were presented a plaque from the Ohio Corporation of Dance Clubs for being the MVDC Honor Roll Dancers.

Norm Sorensen of Cardinal Squares presented a proposal for a new award – the Henry Fowler Memorial – Annual Banner Raid Award. His club is concerned about a lack of emphasis on the Banner Raid program. They propose an annual award to the club with the most raids and retrievals each year. A flyer explaining the award was passed out. He would like to have a vote in July to decide one of three things: (1) to officially create the award and call it the “Henry Fowler Memorial Annual Banner Raid Award,” (2) to officially create the award and call it the “MVDC Annual Banner Raid Award,” or (3) to not create this banner raid award.

### **CONSTITUTION AND BYLAWS PROPOSALS**

Leslie Hyll, chair of the Constitution Review Committee, presented five proposals to update the Council’s Constitution and Bylaws. Copies of these proposals were distributed to each eligible voter during the March meeting. Each proposal was discussed and then voted upon. The results of the voting are as follows:

Proposal 5 – Eligibility for Office – PASSED

Proposal 6 – Officer Changes – FAILED

Proposal 7 – Officer Removal / Filling Vacated Office – PASSED

Proposal 8 – Voting Rights – FAILED

Proposal 9 – Miscellaneous Changes – PASSED

An updated copy of the Constitution and Bylaws will be available at the next meeting. Leslie thanked the rest of the committee, Fay Samborsky, Neil Morrissey, and Iris Maloney, for all of their hard work..

A motion to destroy the ballots was received from Barb Dieterle, second, Betty Fischer. Motion passed.

### **OTHER**

While the votes were being counted, the floor was opened for more comments.

Steve Hayden, Chair of the 2006 State Convention, asked what was liked and not liked about the convention that just ended. Answers included: Sunday morning program was excellent; Fashion show pamphlet was neat; Want more callers from our area to attend; Solo corner was a bust; Line dancing was hard to find; No need to reinvent the wheel – learn from history.

The acting secretary did not hear who made the motion to adjourn the meeting. She assumes it passed. She also forgot to write down what time it ended.
